This letter is intended to satisfy the alternative reporting and disclosure requirement under PWBA Reg. § 2520.104-23 for certain executive deferred compensation plans maintained by Framatome ANP, Inc. (EIN: 54-1536465), 3315 Old Forest Road, Lynchburg, VA 24506-0935. The plans referenced below are maintained by Framatome primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees. The benefits under the plans are paid exclusively from Framatome's general assets, from insurance contracts the premiums for which are paid from Framatome's general assets, or a combination of both.
