

To Our Employees:

This is to inform you of changes to our Employees' Deferred Savings and Profit Sharing Plan (#002). Effective July 1, 1997 the Plan has been amended. The first paragraph in the answer to Question 4 regarding Employer Matching Contributions starting on page 7 of the Summary Plan Description is modified as follows:

“Q.4. What other contributions are made to the Plan by the Employer on my behalf?

If you authorize the Employer to make salary reduction contributions to the Plan for a particular period, the Employer will match your contribution with its own contribution to your account equal to 50% of your contribution, up to the first 4% of you compensation for that period.”
