This registration statement under Department of Labor Regulation §2520.104-23 is filed on behalf of VF Corporation, a Pennsylvania corporation, 1047 North Park Road, Wyomissing, Pennsylvania 19610. VF Corporation's federal employer identification number is 23-1180120.

VF Corporation adopted the VF Executive Deferred Savings Plan effective February 1, 1992. The plan is maintained primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees. As of February 1, 1992, 260 employees were covered under the VF Executive Deferred Savings Plan.

VF Corporation also maintains two other plans primarily for the purpose of providing deferred compensation for a select

group of management or highly compensated employees - the VF Corporation Supplemental Executive Retirement Plan and the VF Corporation Deferred Compensation Plan. The Supplemental Executive Retirement Plan and Deferred Compensation Plan were previously registered under the Top Hat Plan Exemption by registration statement dated March 13, 1986 (copy attached).

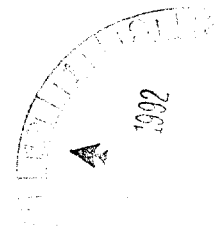
