

Our company, The Minneapolis Clinic of Neurology, maintains a non-qualified "Top Hat" ERISA plan which provides deferred compensation for eight highly compensated employees of our company. It is an unfunded plan so that any future payments would have to be made from general operating sources. It is the only "top hat" plan we have.

This letter is thus our official notification to the Department of Labor about the existence of this plan. Because the plan has been in existence a number of years, we understand the maximum penalty for late filing of this notification statement is \$1,000 under the current DOL amnesty program. We were unaware in earlier periods that such a notification statement was necessary.

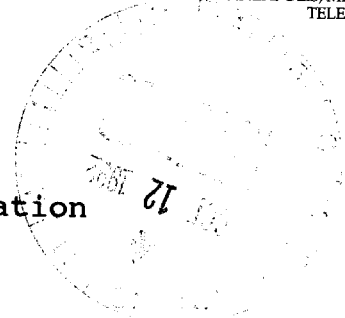

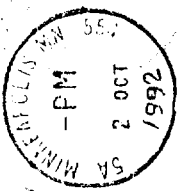
