- (3) Technical Associates of Georgia, Inc. has not adopted any nonqualified plans of deferred compensation. The Plan which is the subject of this Notice has no

participants as of the date of this Notice because no common stock has been issued to any management employee under the Plan as of the date of this Notice.

- (4) Although this filing is made pursuant to Department of Labor Regulations Section 2520.104-23(b), Technical Associates of Georgia, Inc. maintains that the above-referenced Plan is not an "employee pension benefit plan" or an "employee welfare benefit plan" within the meaning of Section 3(1) or 3(2) of the Employee Retirement Income Security Act of 1974 (ERISA). 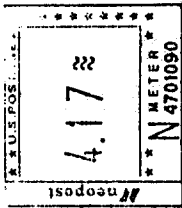
