

This employer maintains a non-qualified deferred compensation plan (agreement) primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees.

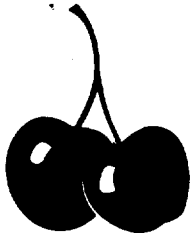

Dear Sir or Madam:

Since 1990 our organization has maintained a deferred compensation agreement with one management employee. We were advised that such a one person agreement was not subject to ERISA filing requirements, and therefore, not required to file a registration statement with the Department of Labor within 120 days of its effective date.

After having reviewed materials regarding the Department of Labor's current amnesty program for Form 5500 filers, we now understand that such a registration statement should be filed for this one person agreement, despite the fact that it does not constitute a "plan" in the usual sense.

You will find enclosed a registration statement for this deferred compensation agreement which is being filed under the current amnesty program along with a check for \$1,000 as required by the program.
