The Plan is being maintained primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees.

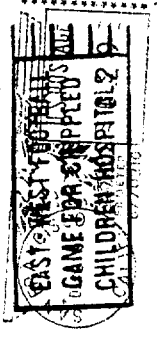
The Federation maintains only the one Plan.
