Additionally, and in accordance with the terms of the amnesty program, we are enclosing a check in the amount of \$ 1,000.00 for this delinquent filing.

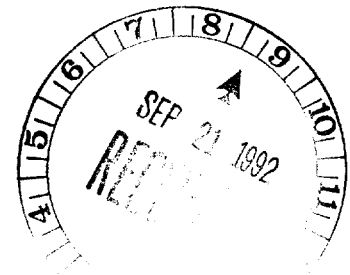
DECLARATION OF PLAN MAINTENANCE
