Gentlemen:

Under the Department of Labor Regulations #2520.104-23, we would like to inform you of the existence of an unqualified deferred compensation plan which meets the requirements of the "top hat" plan exemption. This plan is maintained for two of our top executives. The Plan provides retirement benefits to these individuals upon retirement at age 65 or later, commencing at the instructions of the employee and may be paid in a lump-sum amount or held in trust and paid upon the request of the participant. The plan is funded through life insurance and annuity policies on the lives of these individuals, with Vista Del Mar named as the beneficiary.
