It is our intent to utilize the provisions of 57 F.R. 43477 which allows employers who did not file the required Registration Statement for "top hat" plans in a timely manner. Accordingly, a check for the required penalty is enclosed.

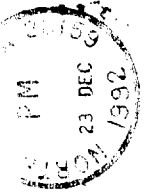
