

Enclosed is check number 006198 in the amount of \$2,000, which you submitted to the Department of Labor (the Department) as payment of late/non-filing penalties for the "Top Hat" plans maintained by Cook-Illinois Corp., under the Department's late/non-filer "grace period".

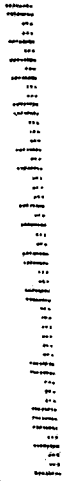
