Please feel free to contact me if you need additional information regarding our plan or the enclosed statement.

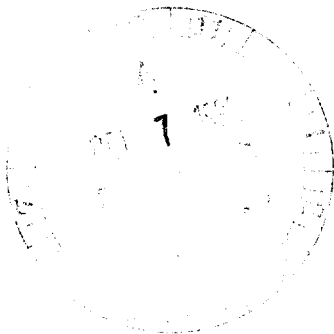
