4. The employer maintains two such Plans and the number of employees that participate in each such plan is as follows:



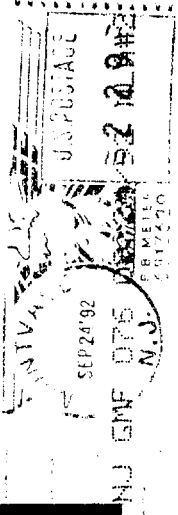
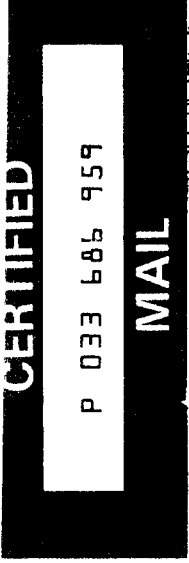
