In accordance with the alternative method of compliance with the reporting and disclosure requirements for top hat plans set forth in Department of Labor Regulation Section 2520.104-23, Money Management International, Inc. (the "Employer") hereby states as follows:

The Employer, located at: 9009 West Loop South, 7th Floor, Houston, Texas 77096, has adopted the Deferred Compensation Agreement primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees.
