Effective June 1, 2006, Labor Ready established, and now maintains, an employee nonqualified pension benefit plan known as the "Labor Ready, Inc. Nonqualified Deferred Compensation Plan" (the "Plan"). The Plan is unfunded and primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees of Labor Ready and its designated affiliated entities. Currently the only affiliated company that has employees who are eligible to participate in the Plan is CLP Resources, Inc. The Employer Identification Number for CLP Resources, Inc. is **EIN: 88-0413057**. The address for CLP Resources, Inc. is:



Currently, the Plan has 68 eligible employee participants (45 at Labor Ready and 23 at CLP Resources, Inc.). Under the terms of the Plan, additional executive officers

may become covered under the Plan. Furthermore, the Plan may be amended by Labor Ready, Inc. from time to time. This filing is intended also to cover the Plan as it may subsequently be amended (or its coverage expanded) from time to time in the future. This is the only nonqualified deferred compensation plan sponsored by Labor Ready or its affiliates.
