This letter constitutes a filing under 29 C.F.R. § 2520.104-23 on behalf of Group Health Cooperative ("GHC"), a nonprofit corporation. The Employer Identification Number of GHC is **EIN: 91-0511770**. GHC's address is:

Effective May 10, 2006, GHC established, and now maintains, an employee nonqualified pension benefit plan known as the "Group Health Cooperative Supplemental Executive Retirement Plan for the Chief Executive Officer" (the "Plan"). The Plan is unfunded and primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees of GHC and its designated affiliated entities. Currently no affiliated company has an employee who is eligible to participate in the Plan.

Currently, the Plan has one eligible employee participating in the Plan. Under the terms of the Plan, additional executive officers may become covered under the Plan. Furthermore, the Plan may be amended by GHC from time to time. This filing is intended also to cover the Plan as it may subsequently be amended (or its coverage expanded) from time to time in the future. This is one of three nonqualified deferred compensation plans sponsored by GHC or its affiliates. The other two being the Group

Health Cooperative Supplemental Executive Retirement Plan for Vice Presidents and Executive Vice Presidents which has 16 participants, and the Group Health Cooperative 457(b) Plan which has 11 participants.

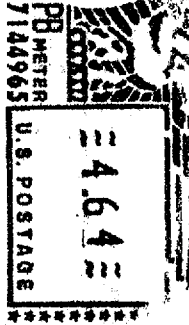
