ERISA NOTICE

ERISA Notice for Unfunded Deferred Compensation Plans

Attached is a sample form of notice which may be used to satisfy the alternative ERISA reporting requirements for an unfunded plan of deferred compensation for a select group of employees. The notice should be filed, preferably on the Employer's letterhead, within 120 days after a new plan is established. Even if the Employer has not previously filed with respect to any prior plan(s), it should include them in reporting the number of plans and employees covered in items 3 and 4.

Plan documents need not be filed, unless they are specifically requested by the Secretary of Labor.

If the Employer fails to file the notice, the plan will be subject to the burdensome reporting and disclosure requirements of ERISA Title I, Subtitle B, Part 1.

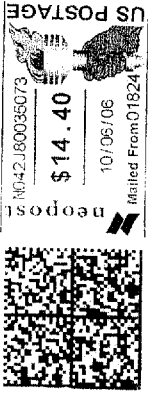

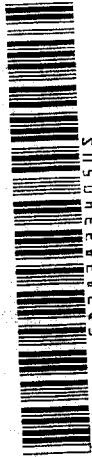
