Under Section 110 of the Employee Retirement Income Security Act of 1974 as amended ("ERISA") and Section 2520.104-23 of the Regulations issued by the Secretary of Labor thereunder, this statement is being filed with respect to a non-qualified deferred compensation arrangement maintained by IMS Health Incorporated for certain of its employees in compliance with the alternative method of compliance with the reporting and disclosure requirement of Part 1 of Title I of ERISA.

The following information is submitted in accordance with the foregoing regulation:

IMS Health Incorporated Executive Deferred Compensation Plan. As of January 1, 2007, zero employees were participating in the plan.

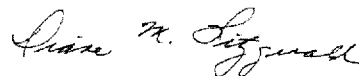
Non-qualified Deferred Compensation Arrangement for G. Pajot. As of January 1, 2007, 1 employee was participating in the plan.
