

Pursuant to Section 2520.104-23 of the Department of Labor's Regulations, this letter will serve as Notice that, with respect to the Meharry Medical College 457(b) and 457 (f) Deferred Compensation Plans (the Plans), the undersigned, intends to use the alternative form of compliance with reporting and disclosure requirements of Part 1 of Title 1 of the Employee Retirement Income Security Act of 1974 (ERISA) which alternative form of compliance is provided in the aforesaid Regulations Section.


Pursuant to Regulations Section 2520.104-23(b), the following information is provided:

- 1) The name of the employer is Meharry Medical College and its address is 1005 Dr. D.B. Todd Jr., Blvd., Nashville, TN 37208-3599.
- 2) The employer's employer identification number is 62-0488046.
- 3) The employer hereby declares that it maintains the Plans primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees.
- 4) Employer hereby states that it maintains two plans primarily for the purpose of providing deferred compensation to a select group of management or highly compensated employees, and the number of employees in such plans is as follows: (a) Meharry Medical College 457(b) Deferred Compensation Plan – 4 employees, (b) Meharry Medical College 457(f) Deferred Compensation Plan – 3 employees.

Pursuant to Regulations Section 2520.104-23(b)(2), the employer will provide documents, if any, to the Secretary of Labor upon request as required by Section 104(a)(1) of ERISA.
