employees of the Employer in the Plan and currently, there are 570 total employees at the Employer. There are 9 employees of Mustang Rental in the Plan and currently 116 employees at Mustang Rental. Mustang Rental is filing a statement under 29 C.F.R. Sec. 2520.104-23 simultaneously herewith for the Plan as well.

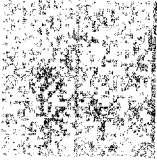
