Mundy Service Corporation maintains the Plan primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees.


4. Top hat plans maintained by Mundy Service Corporation and the number of employees in each:

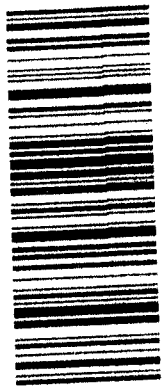
