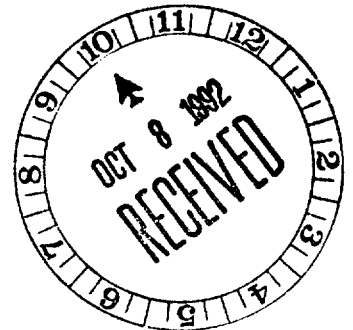

3. Salary Continuation Plan between Matrix Communications Corporation and David C. Ness (effective January 1, 1992).




