
<sup>1</sup>Although one of the four participants is now deceased, his surviving spouse is still receiving benefits as his beneficiary pursuant to the plan's provisions.

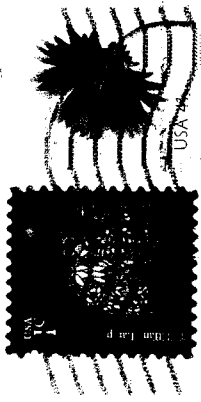
