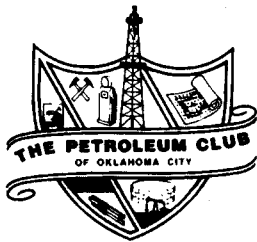

5. The number of employees under the Supplemental Executive Retirement Agreement for Verej Jazirvar: 1.

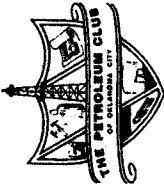
