As such -- and pursuant to such Regulation -- this is to advise you that Pressley Ridge, 5000 Corporate Drive, Suite 400, Pittsburgh, PA 15237, whose federal tax identification number is 25-0965460, adopted The Pressley Ridge School Executive Deferred Compensation Plan effective as of October 26, 2002. The Plan was established primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees. As originally adopted, there were seven (7) employees eligible to participate in the Plan, but the number of participants in this Plan may increase or decrease from time to time. As of the date hereof, the Plan covers two (2) participants.

Box 70933, Charlotte, NC 28272-0933, as permitted under the DFVC Program described in PWBA Notice 03/28/2002.

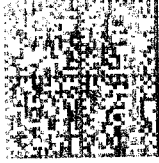
