A predecessor to **Hanesbrands Inc., 1000 East Hanes Mill Road, Winston-Salem, North Carolina 27105, EIN: 20-3552316** (the "Company"), previously notified you of its intent to utilize the alternative form of compliance with disclosure requirements regarding Non Qualified Top Hat Plans. 




