
Number of Plans and Number of Employees in Each Plan

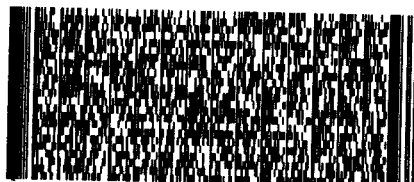

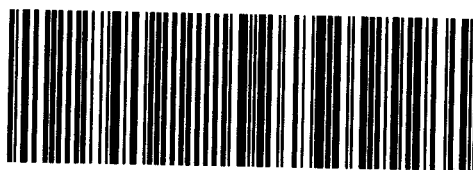
