Ladies and Gentlemen:

This document is being filed with the Secretary of Labor on behalf of Crosstex Energy Services, L.P. ("Crosstex"), in accordance with Department of Labor ("DOL") Regulation Section 2520.104-23, within 120 days of the Crosstex Energy Services, L.P. Severance Pay Plan (the "Plan") becoming subject to Part I of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). This filing constitutes the statement required under DOL Regulation Section 2520.104-23(b)(1), with respect to the Plan, as the alternative form of compliance with the reporting and disclosure requirements of Part I of ERISA for unfunded or insured pension plans (i.e., "top hat plans").


