Effective January 13, 2012, Rosalie J. Perpich, D.D.S., P.A., d/b/a Stillwater Family Dental, adopted a Deferred Compensation Plan (the "Plan"), which provides deferred compensation benefits to a key employee. The Plan provides that deferred compensation benefits become payable upon such employee's separation from service, or upon other events described in the Plan.


