

3. The senior management executive employee is the only participant in the Deferred Compensation Plan arrangement.

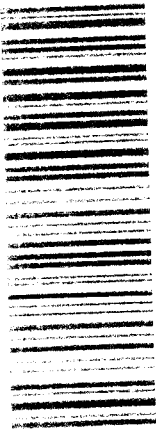
