RE: Notice of Plan of Deferred Compensation

Ladies or/and Gentlemen:

Pine Bluff Sand & Gravel Company, McGeorge Contracting Co., Inc. and Cornerstone Farm & Gin Company sponsor a nonqualified deferred compensation arrangement that necessitates notification to the Department of Labor. 69 employees are covered by such plan presently.

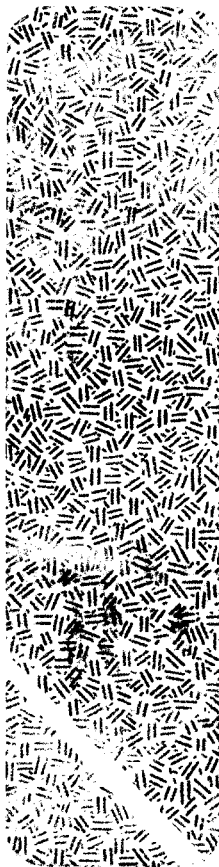
