Re: "Top Hat" Supplemental Executive Retirement Plans of The Christ Hospital

Dear Sir or Madam:

On behalf of The Christ Hospital (the "Employer"), this filing is made pursuant to Department of Labor Regulations Section 2520.104-23.

The Employer has in the past maintained two supplemental executive retirement plans that are unfunded pension plans for a select group of its management and highly compensated employees.

One such plan was known as The Christ Hospital Supplemental CEO Retirement Plan, which plan was effective as of December 1, 2009 and as to which a "top hat" plan registration letter was sent to your office by the Employer on January 4, 2010.

The other such plan was The Christ Hospital Supplemental Executive Retirement Plan, which plan was adopted by the Employer effective as of January 1, 2010 and with respect to which a "top hat" plan registration letter was also sent to your office on January 4, 2010.

This letter is intended to update our registration as to such plans, as follows:

1. The Christ Hospital Supplemental CEO Retirement Plan has been discontinued and replaced by a similar unfunded pension plan that was adopted by the Employer on July 29, 2013 and is named The Christ Hospital 2013 Supplemental CEO Retirement Plan. Such new plan currently benefits one employee of the Employer.
2. The Christ Hospital Supplemental Executive Retirement Plan has been amended and restated by the Employer (through the Employer's July 29, 2013 adoption of a restated document) but is still in effect and currently covers eight employees.



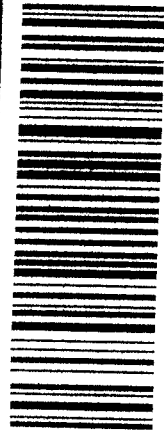

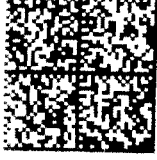
