Pursuant to Section 2520.104-23 of the Department of Labor's Regulations, this letter will serve as notice that, with respect to the Sinclair Broadcast Group, Inc. Post-2004 Executive Deferred Compensation Plan II (the "Plan"), that Sinclair Broadcast Group, Inc. 
