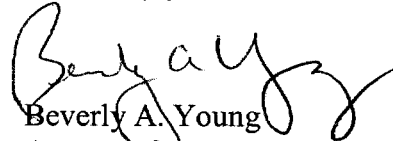

The Employer employs approximately 103 employees and it does not maintain any other nonqualified deferred compensation plans or agreements for a select group of management or highly compensated employees.

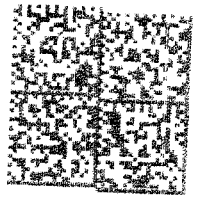
