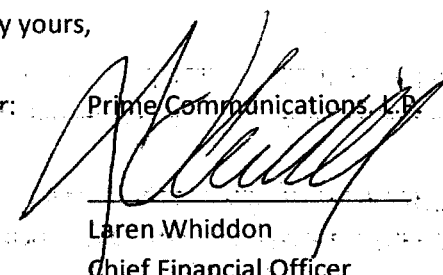
On March 17, 2014, we provided the enclosed notification regarding our intent to establish the Prime Communications Employee Supplemental Savings Plan.

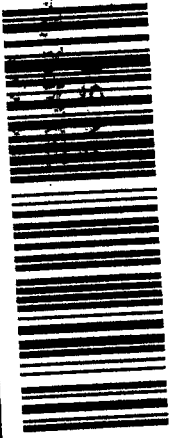
