Pursuant to Department of Labor regulations section 2520.104-23, as authorized by section 110 of ERISA, and the Delinquent Filer Voluntary Compliance Program (DFVCP), I am filing this notice on behalf of California Children's Hospital Association with respect to the above-referenced unfunded deferred compensation plans that were adopted by the employer on December 18, 2013. The employer's name and address are California Children's Hospital Association, 1215 K Street, Suite 1930, Sacramento, California 95814. The employer's federal tax identification number is 95-4306671. The employer maintains each of the plans as a plan primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees. The employer is making a separate filing for a new plan that it just adopted (not a delinquent filing so not being filed under the DFVCP). 
