The Employer will provide plan documents to the Secretary of Labor upon request as required by Section 104(a)(1) of ERISA.

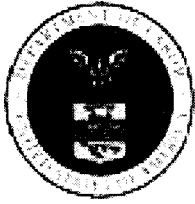
