
Re: Amendment of Disclosure Statement Filed on December 23, 2010

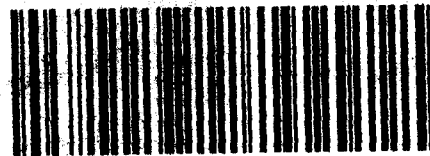
