(3) The Company maintains arrangements primarily for the purpose of providing deferred compensation for a select group of management or highly compensated employees ("Agreements").



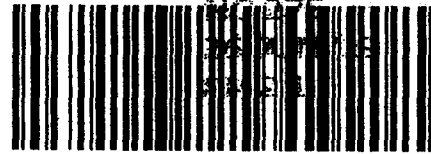
