TO THE PLAN ADMINISTRATOR

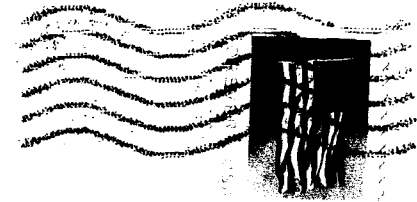
