IMXPORT SERVICES CORP. ("IMXPORT") files this notice solely as a protective measure in the event the Commission Agreement between IMXPORT and James H. Eddy, Jr., dated October 1, 1996, and/or the Commission Agreement between IMXPORT and Eric B. Moore, dated October 1, 1996, is determined to constitute a plan. IMXPORT takes the position that said Commission Agreements do not constitute a plan, but if they do constitute a plan, such plan is an unfunded pension plan maintained by IMXPORT primarily for the purpose of providing deferred compensation for a selected management and highly compensated employees.

In view of the foregoing, the following information is provided as a protective measure for purposes of compliance with §2520.104-23 of the Department of Labor Regulations:

Otherwise, the number of such plans is zero.
