

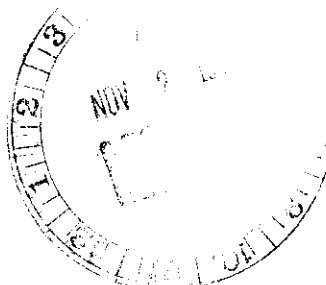

This statement and declaration is submitted pursuant to the provisions of 29CFR2520.104-23(b); it concerns a plan we currently maintain, i.e., the Miner Enterprises Deferred Compensation Plan (the "Plan").

The Plan is an unfunded top hat plan eligible for the alternative method of compliance in connection with the reporting and disclosure requirements of Part I of Title I of the Employee Retirement Income Security Act of 1974, as amended, described in Section 2520.104-23.

We are filing this statement and declaration under the Department of Labor's notice published in the Federal Register (57 FR 43477; September 21, 1992). That notice provides that the Department of Labor will not seek to enforce compliance with the annual reporting provisions of Title I of ERISA, provided we comply with the notice by filing this statement no later than December 31, 1992.

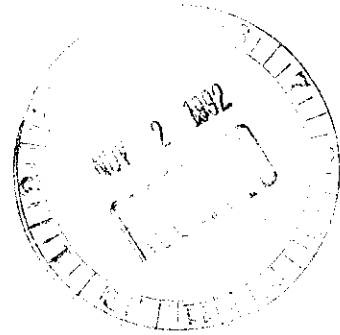

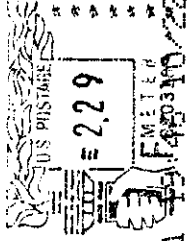
