This plan is known as the Corporate and Subsidiary Officer Capital Accumulation Plan. The Corporate and Subsidiary Officer Plan has 17 participants.

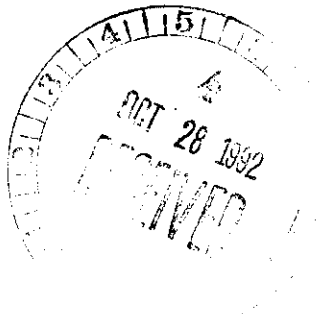
